The Republic of Srpska (hereinafter referred to as "the Borrower") has received a loan from the European Investment Bank – EIB (hereinafter referred to as "the Bank") – towards the cost of the Road Rehabilitation Republika Srpska. This International Invitation for Tenders relates to contracts for the Rehabilitation of ten different sections of Main and Regional Roads of primary national and international importance in Republic of Srpska.

These contracts will include rehabilitation of the following road sections:

Lot 3	M16.1 Klačnice-Prnjavor, 35,9 km, M16.1/M14.1 Prnjavor-Derventa-Derventa (Žirovina), 33,3 km,
Lot 4	M17 Šamac-Crkvina-Modriča, 20,7 km, M17 Modriča-Šešlije, 27,5 km,
Lot 5	M14 Otoka-Novi Grad, 17,7 km,
Lot 6	M14.1 Vrbaška-Gradiška, 7,13 km i
Lot 7	R452 Milići-Derventa-Rudnik, 19,0 km.

These contracts are expected to be implemented from August 2007 to December 2007.
